MOTHER AND FATHER, OR LEGAL GUARDIAN

Having discussed with your son the competitive program of boys' baseball afforded by B.B.I. and believing it to be beneficial to him, we hereby agree for him to participate as a member of the team named above. Whether he is in the line-up or on the bench, we realize if he quits prior to the end of his eligibility or before he is officially released, he will not be eligible to play for any team in B.B.I. for a period of one year.

We agree that by our conduct we will set an example in good sportsmanship, to support and encourage our boy and his teammates. We understand that alcoholic beverages are not permitted at or near any game or other team function. We accept this with the knowledge that any violation or demonstration of poor sportsmanship by our guests or us at games, practices, or other team activity, will subject our son and us to expulsion from any or all B.B.I. activities.

AFFIDAVIT OF INDEMNITY

We are aware that Boys Baseball, Inc. of Dallas (B.B.I. herein) is a non-profit organization and that its directors, officers, manager, coaches, employees, and sponsors, perform in various volunteer capacities.

As inducement to B.B.I. to accept this player in the baseball program offered by B.B.I. in the Dallas Metroplex, we hereby waive any and all claims and causes of action for damages for personal injuries or otherwise to the player which may arise by virtue of acts, or omissions to act, negligent or otherwise, on the part of B.B.I. or American Amateur Baseball Congress, Inc., and all of their respective directors, officers, employees, managers, coaches, agents, umpires, scorers, and sponsors (all indemnities herein), and agree to hold said indemnities harmless and indemnify them against all claims. This Affidavit of Indemnity extends to any claim, suit, or action brought by the player or on his behalf, or by or for my (our) benefit, or by or for the benefit of any other person or entity, it being my (our) specific intent to fully indemnify and hold harmless the indemnities listed herein without limitation of any kind as to party, nature of claim, amount of claim or time interval involved.

I (we) understand and agree that B.B.I. directors, officers, managers, coaches, employees and sponsors have no obligation to pay, or furnish insurance to pay, any medical, dental, or hospital bills that may be incurred by any player. I (we) hereby accept sole responsibility for any such bills that may arise from injury to the player. If the player is injured, I (we) agree to hold harmless and authorize anyone available to provide him first aid or emergency treatment that may be deemed appropriate at the time.

I (we) further waive any and all rights, claims, actions, causes of actions or suits I (we, or either of us) may have or may hereafter have as a result of any personal injury or property damage I (we) might incur while in attendance at any practice, scrimmage, game or other activity of B.B.I. This Affidavit of Indemnity extends to any claim, suit or action brought by me (us) for or on my (our) behalf, or for or on behalf of any other person or entity, it being my (our) specific intent to fully indemnify and hold harmless the indemnities listed herein without limitation of any kind to party, nature of claim, amount of claim or time interval involved.

I (we) fully understand the import and significance of signing this Affidavit of Indemnity and have secured the advice of an attorney if I (we) deemed it necessary to my (our) full understanding. I (we) further understand that B.B.I. has no obligation to accept the player as a participant, and I (we) deem it a material benefit and sufficient consideration for the giving of this Affidavit of Indemnity.
